Tuesday, Wednesday morning, Thursday and Saturday.

We're excited to welcome students back into our school safely!

REOPENING THIS FALL

For the safety of our Students, Faculty and Staff, TSA will be:

- Providing enhanced cleaning protocols throughout the school
- Limiting in-person class enrolment to 6-8 students depending on the size of the studio,
- Setting out physical distancing markers in common areas
- For the most part eliminating shared tools (where they must be used a cleaning bucket will be provided)
- Providing hand sanitizer and cleaning materials
- Staggering class starts
- Insisting on mandatory face coverings
- Implementing screening and tracking procedures.

TSA's physical layout, such as cross-ventilation through windows, and its responsible community of students, faculty and staff makes reopening possible.

NEW POLICIES FOR REGISTRATION THIS FALL

When registering for IN-PERSON courses this Fall, students will notice new **Terms and Conditions** in order to register (which appears at the box prompt - this is the document that is checkmarked when finalizing registration). This now includes our General Withdrawal and Refund policy, along with IN-PERSON Policies and Procedures during COVID-19, and our TSA Agreement and WAIVER of Liability - these must be agreed to in order to register for courses.

IN-PERSON TERM AND ALTERNATIVE PLANS

Our IN-PERSON courses will mostly be 5 week sessions, back to back, designed to be stand alone or to be taken consecutively.
